# "PARK 2 WIN - SOUL2SOUL" JETSET PARKING CONTEST:

JETSET PARKING'S "PARK 2 WIN - SOUL2SOUL" CONTEST (HEREIN THE "CONTEST") SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE NECESSARY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THE CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (HEREIN THE "CONTEST RULES").

## 1. ELIGIBILITY

To be eligible for this Contest, an individual must:

- (a) be of the age of majority in Alberta, Canada; and

Subject to Section 6 herein, enter the Contest by booking a parking stay online using one of the three (3) valid promo codes at jetSet's website (<a href="www.jetsetparking.com/yeg">www.jetsetparking.com/yeg</a>). Bookings must be made by 11:00p.m. on May 28th, 2017. Alternatively, participating in the SOUL2SOUL jetSet Jam on jetSet's facebook page, during the Contest Period, will qualify as a no purchase necessary entry (<a href="www.facebook.com/jetSetParking">www.facebook.com/jetSetParking</a>).

#### 4. PRIZE SPONSORS

The Prizes are sponsored by Edmonton Regional Airports Authority (dba jetSet Parking), (also referred to as Edmonton Airports) (hereinafter referred to as the "Sponsor"). The Sponsor acknowledges that the Sponsor and the Contest are not in any way affiliated with, maintained by, authorized by, endorsed by, or sponsored by Faith Hill, Tim McGraw, Road Dog Touring, Inc., Danda Films, Inc. or any of its affiliates.

#### 5. MAIN PRIZE

There is one (1) main prize, as follows:

One (1) main prize ("Main Prize") consisting of four (4) premium tickets to the Tim McGraw and Faith Hill SOUL2SOUL concert live in Edmonton on Saturday, June 3, 2017, at 7:30p.m. The Main Prize is valued at approximately at \$860.

## 6. VALID ENTRIES

In order to be eligible for a Main Prize, valid entries must be received within the Contest Period and in accordance with these Contest Rules. Entry requirements are as follows:

(a) Entries may be made online by booking a parking reservation with jetSet Parking Edmonton, using promo code SOUL2SOUL or SOULTOSOUL;

- (b) Entries may also be made by participating in jetSet's Facebook "SOUL2SOUL jetSet Jam" between May 8, 2017 to May 28, 2017;
- (c) All entries become the sole property of the Sponsor and none will be returned for any reason;
- (d) All entries must be received no later than the end of the Contest Period;
- (e) Entries will be declared invalid if they are cancelled, lost, late, illegible, incomplete, irregular, forged or mechanically reproduced.

### 7. ELIGIBILITY

#### 8. GENERAL RESTRICTIONS CONCERNING PRIZES

Before being declared a Main Prize winner, the potential winner shall be required to answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question during a pre-arranged telephone call or face to face meeting, comply with these Contest Rules, and sign and return the Prize Declaration and Release form (defined below);

These Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsor.
